Open Discussion

Mike Guinan gave the Board an update on the Eastview project. The court rejected the Town's reasoning regarding the condemnation of the Lord & Taylor building. Then next option for the Town is to appeal which would take another 30 days. The Town board agreed that they do want to keep pursuing the appeal process. The court said that Willmorite did not give enough data as to why they want to go through with the condemnation. Mike Guinan assured the VLDC board that none of this has cost the Town anything to go through this process because it is being covered by Wilmorite. Because the Lord & Taylor storefront is dark, it is a huge loss in sales tax revenue. Overall, the town is on hold for 30 days or more depending on what the court does with their action, but they will be taking the next steps to get the storefront back.

Kathy reviewed the Town Economic Development budget and discussed the VLDC budget with the Board for 2023. Joe Corsi and Kathy discussed the Façade program updates with new criteria and determining how much money to allocate from the VLDC
