## Payment of Bills - Abstract \#5

The Board reviewed the abstract to be paid from the Victor Local Development Corporation. The abstract totaled \$6,089.79.

## Executive Director Report- Discussion

Kathy went over the Victor Business Awards financials and a recap of the event to the VLDC Board because the last Business Awards event was done in 2019, before the pandemic. She compared the costs from 2022 vs. 2019. In 2022, they received $\$ 9,750$ in sponsorships. In 2019, they received $\$ 10,700$ in sponsorships. The VLDC had a profit of $\$ 5,226$, which will be going into the loan program. Kathy used a local business, Mobile Graphics, to make all the invitations, plaques, and programs. This year she recieved a lot of good feedback from the attendees and winners.

## Revisiting VLDC Projects

## Façade Improvement Program

## Status:

The program was a joint effort between the VLDC and Village Urban Renewal Agency and awards grants for projects that improve the exterior of Village buildings. There was a defined target area within the Village and the funding had not exceeded $\$ 2,000$. Funds have been used for signage, windows, doors, paint and more. The VLDC designates $\$ 10,000$ to this program annually.
In 2020, they used the funding for COVID relief but did not do the program in 2021.

## Decisions/next steps:

1. Is the board in agreement to continue with the Façade program and implement for the remainder of 2022?
2. Would need two board members to be part of a committee to review current program and be ready to launch it end of June.

## Incubating Entrepreneurs

## Status:

This was a priority project outlined in the 2018 Strategic Plan that was completed for Economic Development initiatives. The VLDC attempted to purchase 14 Railroad street in 2021 to pursue this concept. They have a plan that was developed based on that building and includes potential funding mechanisms and partners.
The board has also discussed the possibility of looking at other sites.

## Decisions/Next Steps:

1. Is the board interested in pursuing 14 Railroad with a developer?
2. Is the board interested in pursuing other sites?

## Developers Forum

## Status:

Proposed in 2019 - create an event showcasing available sites/property in Victor. This would be targeted towards developers/real estate professionals. The group had developed a mission statement: position Victor as the most ideal community for current and future residents, students, merchants, industrialists, developers \& entrepreneurs. They were considering a lunch/evening event with some representation from County \& Town. Possible "familiarization" tour of the area etc.

## Decisions/Next Steps:

1. Does the board want to pursue a Developers forum for the fall of 2022?
2. Need board members to re-group and bring concept back to the VLDC board
3. Determine Budget

## Market Victor

## Status:

Priority project identified in the 2018 Strategic Plan and could run parallel to the Developers forum. The concept is to market to new businesses - retail/restaurant - to locate in Victor.

1. Does the board agree that the marketing piece should/could be a part of the Developers forum?
2. Retail/Restaurant focus?

## Revolving Loan Program

Status: Liz and Alyssa met to review current loan application used by the VLDC and provide suggested changes. The following changes/updates were discussed

1. Raise the rate to $3.50 \%$
a. This is currently at $2.5 \%$ and is taken off the top rather than added to each payment
2. Charge an application fee regardless of approval or not, The fee suggested is \$50.00
3. Make sure the client provides a copy of their Business paperwork (dba, LLC, Corp)
4. Any Loan over $\$ 20,000$ ask for them to secure life insurance and they are the assignee
5. Place a UCC filing ( $2^{\text {nd }}$ place is fine) - Please ask the attorney if they have the right to be able to do that with us being a not for profit.
a. I did inquire with the Harris Beach attorney

## Decisions/Next Steps:

1. Is the board in agreement with the above mentioned changes?
2. Kathy to update application to reflect changes if approved.
3. Funds for Town loans - currently they do not have any funds to lend to businesses outside the Village.

## Open Discussion

Board member Joe Corsi is interested in relaunching the Façade improvement program. He would like to be on the committee to help the village businesses improve their exterior and/or signage. The board members agree that this is a really good program to relaunch.

The board discussed the "Incubating Entrepreneur" project, whether they should pursue 14 railroad street with a developer or look at other sites. They discuss what direction they would like to see the project go and where the potential vendors would prefer to be. They have created the plan, but the location is the question.

They decided instead of doing a Developers Forum, there should be a marketing campaign for Victor. They want people to think about Victor and what Victor offers to bring potential businesses, developers, and visitors to the town.

Meeting was adjourned on a motion by Vince Pettrone, seconded by Ted Rund Jr. and unanimously approved at 9:08am.
